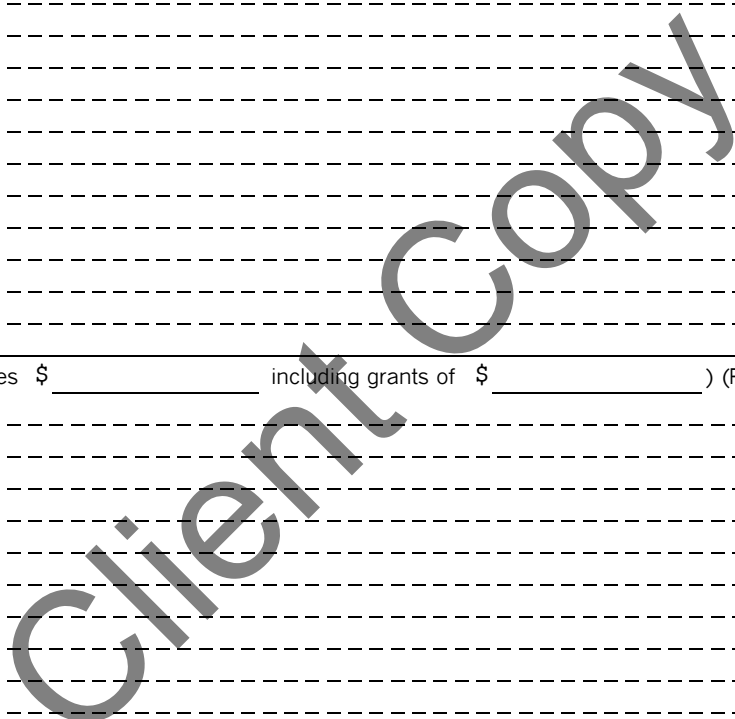

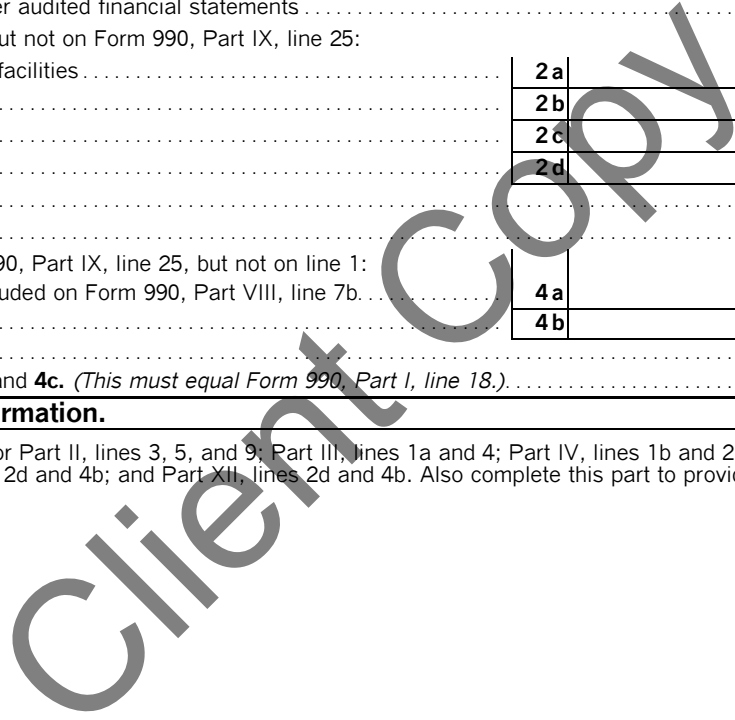

WE EDUCATED THEM ABOUT SOURCES OF PFAS CONTAMINATION AND THE NEED FOR FEDERAL POLICY THAT ADDRESSES THE ENTIRE CLASS OF PFAS. OUR MAJOR FOCUS WAS GARNERING SUPPORT FOR AN AMENDMENT TO THE FAA REAUTHORIZATION ACT OF 2018 THAT WOULD GIVE CIVILIAN AIRPORTS THE FREEDOM TO CHOOSE FIREFIGHTING FOAMS WITHOUT PFAS. WE ALSO CONTINUED TO HOST MONTHLY WEBINARS TO EDUCATE HILL STAFF ON NEW DEVELOPMENTS AROUND PFAS. WE FOUND PFAS IN SOME CARPETS MARKETED AS "PFAS-FREE." BUYER'S CLUB MEMBERS INVITED HIGH-LEVEL REPRESENTATIVES FROM COMPANIES PRODUCING 92% OF THE U.S. CARPETS TO OUR WORKSHOP IN FEBRUARY 2018. DURING THE MEETING, CLUB MEMBERS, ACADEMIC AND GOVERNMENT SCIENTISTS, AND BUSINESS EXECUTIVES WHO NO LONGER USED PFAS ENCOURAGED THE CARPET INDUSTRY LEADERS TO STOP USING ALL PFAS IN THEIR CARPETING. BY THE END OF THE DAY MUCH OF THE CARPET INDUSTRY HAD AGREED ON THE NEED TO DO SO. B. IDENTIFYING PFAS IN GROCERY STORE PACKAGING: WE COLLABORATED WITH PROF. GRAHAM PEASLEE AT UNIVERSITY OF NOTRE DAME TO TEST FOR PFAS IN DISPOSABLE FOOD SERVICE PRODUCTS FROM BUYER'S CLUB MEMBERS' FACILITIES.
