WE WILL EDUCATE GROCERY RETAILERS ABOUT THE PFAS IN THEIR PRODUCTS AND ENCOURAGE THEM TO ASK FOR PFAS-FREE PACKAGING FROM GROCERY MANUFACTURERS AND PACKAGING SUPPLIERS.

HOLDING POLLUTERS RESPONSIBLE FOR PFAS CLEANUP: PETITION TO EPA ON DESIGNATING AS PFAS HAZARDOUS SUBSTANCES: DESPITE AMPLE SCIENTIFIC EVIDENCE THAT PFAS CONTAMINATION IS HARMFUL TO HUMAN HEALTH AND THE ENVIRONMENT, THEY ARE NOT REGULATED UNDER THE U.S. SUPERFUND LAW THAT DRIVES CLEANUP OF HAZARDOUS WASTE SITES. ATTORNEY ROB BILOTT, WHO HAS WORKED FOR TWO DECADES TO OBTAIN JUSTICE FOR PFAS-CONTAMINATED COMMUNITIES, HAS SAID THAT A SUPERFUND DECLARATION IS THE SINGLE MOST IMPORTANT POLICY PRIORITY FOR PFAS.
